- This includes 273,188 unvested restricted stock units.
- The forfeiture reported in this row represents shares that were withheld by the Company solely for the purpose of satisfying tax obligations arising upon the issuance of 8,830 shares pursuant to the Company's 2015 Salary-for-Equity program.
