Explanation of Responses:

Reporting Person elected to participate in this program and receive payment of 50% of his base salary in shares of the Company's common stock. The number of shares issued was determined by (i) dividing 1/12 of Reporting Person's enrolled salary by (ii) the trailing 30-day closing average of the Company's common stock (\$2.15 / share), rounded up to the nearest whole share.
- This includes 555,177 unvested restricted stock units.
- The forfeiture reported in this row represents shares that were withheld by the Company solely for the purpose of satisfying tax obligations arising upon the issuance of 6,304 shares pursuant to the Company's 2015 Salary-for-Equity program.
- The forfeiture reported in this row represents restricted stock units that were withheld by the Company solely for the purpose of satisfying tax obligations arising upon the automatic vesting of 60,823 restricted stock units.
