- This includes 235,688 unvested restricted stock units.
- The forfeiture reported in this row represents shares that were withheld by the Company solely for the purpose of satisfying tax obligations arising upon the issuance of 8,935 shares pursuant to the Company's 2015 Salary-for-Equity program.
